SAFETY GUIDELINES OF COVID-19

Based on our commitment to provide a safe environment, and to organize a successful and fruitful exhibition for all participants, including exhibitors and visitors alike, and in compliance with the precautionary instructions and guidelines issued by the health authorities in the State of Qatar, the Qatar International Agricultural Exhibition will be organized within clear and strict preventive measures that take into account the standards of social distancing, non-contact, hygiene, sterilization and protection from infection.

GENERAL SAFETY MEASURES

ENTRANCE MEASURES

- It is strictly forbidden for individuals under the age of 18 and over the age of 65 years to enter the exhibition.
- The number of visitors inside the halls will be tracked through a smart tracking system to ensure that there is no overcrowding.
- Everyone, including employees, organizers, visitors, exhibitors and suppliers, are required to show the green status on the "Ehtiraz" application on their mobile phones when entering from any of the exhibition entrances.
- The temperature of everyone, including employees, organizers, visitors, exhibitors and suppliers will be examined through thermal scanning cameras distributed at all entrances to the exhibition, and only those whose temperature is 37.8 degrees or below will be allowed in.
- All doors (except fire protection doors) will be opened for contactless use.
- Entry is permitted only for exhibitors who hold identification cards issued by the organizer, and visitors who have previously registered via the website and obtained the identification code by e-mail (QR Code).

SOCIAL DISTANCING MEASURES

- Walkways will be expanded between exhibition stands to ensure a comfortable and safe flow of visitors and to ensure that a safe distance is maintained.
- The number of individuals present inside each stand will be limited to only two people in every 12 square meters, with the necessity to maintain a distance of two meters between them as a minimum at all times.
- All exhibitors and visitors are obligated to avoid contact as much as possible (no handshaking or business cards exchanging...)
- All exhibitors are obligated to provide electronic payment solutions to visitors wishing to purchase their products, and to avoid cash transactions.

PERSONAL PROTECTION MEASURES

- Everyone, including employees, organizers, visitors, exhibitors and suppliers, are obligated to wear masks during the exhibition and not to take them off for any reason whatsoever.
- Everyone, including employees, organizers, visitors, exhibitors and suppliers, is obligated to repeatedly sterilize hands. Sterilizers and disinfectants will be provided to all exhibitors by the organizers in Hygiene Packages, and automatic hand sanitizer dispensers will be sufficiently distributed throughout the exhibition.

STERILIZATION & CLEANING PROCEDURES

- All parts of the exhibition will be sterilized daily before opening and after closing, including exhibition stands and exhibits.
- The exhibition will be closed for one hour every day from two to three in the afternoon, to allow the participants to have lunch and re-sterilize the exhibition.
- Boecker will sterilize the supply materials at the loading doors before letting them enter using a product registered with the Environmental Protection Agency and approved by the US Food and Drug Administration (FDA).
- The toilets will be open, clean and frequently sterilized throughout the day.

PRE-REGISTRATION PROCEDURES FOR VISITORS

- By registering through the exhibition's website, visitors will receive an identification code (QR Code) via e-mail, and they must present this code at the exhibition entrances.
- In case there is no prior registration, visitors will have an online registration service at the exhibition entrances. To benefit from this service, the visitor must have a smart phone device connected to the Internet, and an active e-mail on the device.

FOOD AND DRINKS

- It is strictly forbidden to provide food and drinks within the exhibition halls, including coffee and other food and drinks except in the dedicated zones that will be allocated by the organizers.
- Exhibitors who wish to provide free food samples of their products must commit to prepacking these samples in advance.

AWARENESS & GUIDANCE INSTRUCTIONS

- Awareness posters will be distributed throughout the exhibition to promote health and safety protocols.
- During the event days, health, safety, physical distancing and hygiene guidelines will be announced frequently through the voice announcement system.

MEDICAL ASSISTANCE

 Red Crescent crews will be present throughout the exhibition period, and the emergency medical service will be available all the time, including a temporary isolation room, in case that any contractor, exhibitor, visitor or supplier shows any symptoms.

INSTRUCTIONS FOR EXHIBITORS

INSTRUCTIONS FOR EXHIBITORS

BEFORE THE EXHIBITION

- Communicate with the contractor responsible for your platform on time regarding implementation of safety and health regulations.
- Keep the design of your platform simple, to maximize available open space and platform features.
- · Ensure that the platform design allows social distancing.
- Manage the number of workers on site during preparation and construction.
- We encourage every exhibitor to do a PCR test for all his workers and exhibition participants before 48 to 72 hours before the fair exhibition as an additional precaution measure.

ENTRY TO THE EXHIBITION

- At the entrance, a temperature check will be performed on arrival via thermal scanning cameras.
- Show your EHTERAZ app which must be in green status to enter.
- Get your own exhibitor kit from exhibition before the opening.

STAND CLEANLINESS

- The exhibition will be closed from 2 pm to 3 pm for sterilization, and all stands will be sterilized daily after the end of the exhibition.
- Exhibitors must clean their stand and exhibits regularly throughout the event while constantly sterilizing frequently touched items such as exhibits, tables, chairs, and pens.
- Achieving a balance between the total capacity of customers and employees on the display stand at any time during the exhibition days.
- Social distancing should be maintained during personal discussions with visitors.

INSTRUCTIONS FOR EXHIBITORS

REVIEW VISITS

• Boecker will conduct a daily check of the platforms, to ensure that all safety measures are maintained, comply with local regulations, ensure hassle-free government inspections and fix defects in applications and procedures. Please cooperate when checking your stand.

PROMOTIONAL ITEMS & FOOD SAMPLES

- Consider contactless alternatives (electronic and digital) for sharing, promotional materials and gifts.
- We do not encourage the exchange of business cards. Use electronic cards if possible.
- In the case of offers to visitors, please use pre-packed products. Exhibitors who wish to present free samples of their products must commit to packing and packaging these samples in advance.
- Food is not allowed inside the showrooms (except in dedicated areas).
- · Avoid serving open or exposed food to visitors

VISITOR INSTRUCTIONS

VISITOR INSTRUCTIONS

BEFORE THE EXHIBITION

- The necessity of pre-registration through the website of the exhibition.
- Set a date and time to conduct business conversations with the desired exhibitors as early as possible.
- Self-registration is free on the exhibition's website or on the mobile app. Scanning the QR code at the door will allow visitors to easily pass through the registration and reduce physical contact with other visitors.
- Registration on the event site will be personal. Personal registration via mobile phone through the event website and mobile application.
- Personal assistance at the event site will be available with respect to social distancing between the host and the registrants.

EXHIBITION ENTRANCE

- All visitors must undergo a temperature check before entering the exhibition. If the thermal camera detects a high temperature, the visitor will be asked to go to the isolation area.
- · Show your EHTERAZ app which must be in green status to enter.
- A mask must be worn at all times. Entry without a mask is not allowed.
- · Children under the age of 18 are not allowed.

PERSONAL HYGIENE

- Encouraging regular hand washing or the use of alcohol for sterilization.
- · Avoid touching your mouth and nose.
- Cover your mouth and nose with your sleeves or a tissue when coughing or sneezing.
- A safe distance should also be maintained during personal discussions with exhibitors.
- Encouraging a non-contact policy (for example, no handshaking or business cards exchanging)
